For "Supply, Delivery, Installation, Testing & Commissioning of Electro-Mechanical Equipment" of Khakari Gad Micro Hydropower Project, Dilasaini Gaunpalika-1, Baitadi

1. On behalf of Khakari Gad Micro Hydro Project User's Committee (KGMHPUC), AEPC/NRREP invites sealed bid from the registered eligible and qualified Suppliers/Bidders for the procurement of Goods "Supply, Delivery, Installation, Testing & Commissioning of Electro-Mechanical Equipment of Khakari Gad Micro Hydro Project, 97 kW" Dilasaini Gaunpalika - 1, Baitadi District under National Competitive Bidding (NCB) procedures specified in Public Procurement Act (PPA) and Public Procurement Regulations (PPR) and as per the required specifications mentioned.
2. Interested eligible Bidders may obtain further information and inspect the bidding document in English at the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal during office hours.
3. Complete set of Bidding Document in English may be purchased from the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal during office hours on all working days by eligible Bidders 3 December 2018 onwards on the submission of a **Written Application**, copies of **Company/Firm Registration** and **VAT Registration** certificates and upon payment of a non-refundable fee of NRs. 5,000.00 and the Bid document shall be available for sale up to office hours till 1 January 2019.
4. Pre-bid meeting shall be held at AEPC, Khumaltar Height, Lalitpur, Nepal at 11:00 A.M. on 20 December 2018.
5. Sealed bid must be submitted to the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal by hand/ courier on or before 12:00 Noon on 2 January 2019. Bids received after this deadline will not be accepted.
6. Bid must be valid for a period of 90 days, counting from the day of bid opening and must be accompanied by bid security, amounting to minimum NRs 700,000.00 (In words: Seven Hundred Thousand Only), which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum 1 May 2019).
7. If bidder wishes to submit the bid security in the form of Cash, the cash should be deposited in AEPC's Office Code 28-331-01 and Account Name DTCCO, Lalitpur, Bank Account No. 16856 KHA 3 at Nepal Bank Ltd., Gabahal, Lalitpur Branch and submit the original receipt of the deposited amount of cash along with the sealed Bid.
8. Received sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at **12:30 PM on 2 January 2019** at the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal. But nothing shall bar the opening of Bid by the reason only that any bidder or its agent is not present. Bidder's representative should bear with authorization duly signed by the authority of firm at the time of Bid opening.
9. If the last date of purchasing, submission and opening of bids falls on a government/public holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. AEPC/NRREP and User committee shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of Bids. The bidders are advised to visit and assess the actual site conditions before submitting their bid.
11. AEPC/NRREP and User's Committee reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
