**General Terms and Condition for Prospective bidders:**

i. All the bidders shall submit Earnest money (EMD) of **NPR 8,400/- (Nepali Rupees Eight Thousand Four Hundred only)** in the form of Banker's Cheque /Demand Draft/Bank Guarantee issued by a Nationalized/Scheduled/Commercial Bank in favour of Embassy of India, Kathmandu along with the Quotation. The validity of the EMD should be minimum 30 (Thirty) days from the date of opening of the Quotations.

ii. Bidders are advised to make an inspection of the items to be disposed before submitting their Quotations. No variation in amount or any other conditions would be entertained after submission of the Quotation.

iii. Bidders are required to quote prices in the Performa Annexed (Bid Form) with the bid document both in figures and in words and the currency must be Nepali Rupees only. In case of any discrepancy between figures and in words, the total amount quoted in words shall be taken to be correct for this quotation.

iv. No Conditional quotation shall be accepted.

v. Highest bid (H1) will be the evaluation criteria for selection of successful bidder.

vi. After award of work, Successful bidder shall have to deposit the Full amount within 05 working days.

vii. EMD of Successful bidder/s will be forfeited, in case the bidder does not show interest in depositing the Full amount. The EMD of the unsuccessful bidders will be returned subsequently. The EMD of the successful bidder will be returned after successful completion of work.

viii. It is advised that all the items should be removed within 07 days after the award of work. Embassy shall not be responsible for misplace or loss of any item after award of work. In case of non-removal of the items within the stipulated period without any justified reason for delay the Embassy may cancel the award of work and forfeit EMD. The decision of the Embassy in this regard will be final.
