The Government of Nepal [GoN] has allocated funds and received a grant from **Government of India (GOI)** towards the cost of Post Earthquake Reconstruction School Project and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Nine School Building Complexes in Ramechhap and Dolakha District (**GOI/CLPIU(E)/2076-077-Dhading-01 and GOI/CLPIU(E)/2076-077-Kavre-01** ). Bidding is open to all eligible bidder from Nepal and India.
2. Central Level Project Implementation Unit (Education) invites electronic bids from eligible bidders for the construction of RCC framed School buildings, toilets, water supply and electrical facilities including furniture under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
