3. The bidding amount would be start with a minimum value of NRs. Bids/Sealed tenders in the name of Head of Chancery, Embassy of India, Kathmandu should reach the Embassy of India, Kapurdhara Marg, Kathmandu by 1700 hrs on 14th June, 2023 along with bid security of **NPR. 10,000/- (Ten Thousand only) for each vehicle as demand draft** in favour of Embassy of India, Kathmandu. The bids will be opened in the office of Head of Chancery/SS(Admin) on 15th June, 2023 at 1100 hrs. The parties and their representatives may be present at that time.

4. Interested bidder may bid for one vehicle or both the vehicles at the same time. It may also be noted that it would be sole responsibility of buyer to complete all the legal formalities viz. getting the vehicle registered on his/her name as well as paying all types of taxes to the local authorities. Only after making full payment of the vehicle/vehicles to Embassy and completing all the formalities related to payment of taxes, the vehicle/vehicles will be handed over to the successful bidder.
