<u>NOTICE</u> <u>Certificate Course of Rashtriya Ayurveda Vidyapeeth,</u> <u>New Delhi (CRAV)</u>

Embassy of India, Kathmandu invites applications from Nepalese nationals possessing a BAMS or equivalent degree recognized by CCIM for joining one year full time Residential Certificate Course of Rashtriya Ayurveda Vidyapeeth, New Delhi (CRAV). The course will be offered through some selected training centers of RAV already identified for the purpose.

2. Eligibility Criteria:

Candidates desirous to apply should fulfill the following criteria :

(i) Foreign nationals who have completed BAMS in India (as a sponsored candidate) from a CCIM recognized institution in India.

(ii) Foreign nationals possessing a BAMS or any equivalent degree recognized by CCIM procured in a country other than India.

(iii) Candidates must have good proficiency in English.

(iv) Candidates should be medically fit.

3. Objective of the CRAV course :

The CRAV course intends to provide clinical expertise and skill enhancement pertaining to disease diagnosis, treatment and drug formulations under the guidance of some eminent practicing physician / rasa vaidya of Ayurveda from India.

4. <u>Method of Admission :</u>

Interested candidates who fullfill desired essential qualification as specified are required to apply through Indian Embassy. The session will start from May-June. Candidates will be selected on the basis of their justification of need of the training and the prospects of the utilization of the training in furtherance of Ayurveda in their own country. The last date for submission of application is 21.02.2020.

5. <u>Selection of training centers / Guru :</u>

In most cases, if the candidate has a particular choice of a subject /training center / guru, it would be made available subject or the availability of that center / guru in the corresponding year. In the other case, the candidate may be given an opportunity to choose among available places.

6. <u>Medium of training</u>:

The medium of instruction is English.

7. Examination :

Every CRAV student has to appear in term examination upon completion of the course. This will include a theory and a viva voce exam. Other regular activities as are imparted upon Indian CRAV students would also be required to be completed by foreign students.

8. <u>Award of certificate :</u>

Successful candidates will be awarded with the CRAV certificate during the annual convocation of RAV.

9. <u>Stipend :</u>

No stipend would be given to candidates.

Every employed applicant would be required to submit a 'No Objection Certificate' from his employer. Employed and self employed both candidates are required to submit an undertaking of the intent that they are capable of bearing the cost of living and accommodation in India during the period of their training in India. Candidates are required to give an undertaking that in any case they would not be staying in India once the course is completed.

10. <u>Selection process:</u>

An English test / interview would be held in Embassy of India, Kathmandu to select deserving students. Selection of candidates in the interview does not guarantee admission in CRAV unless their placement is confirmed by Rashtriya Ayruveda Vidyapeeth (RAV), an autonomous organization under Ministry of AYUSH.
