## Invitation for Bids for the Madan Bhandari International Football Stadium at Damak-3, Jhapa, Nepal IFB No: NCB/Works/MBIFS-06/077/78

- The Government of Nepal [GoN] has allocated funds towards the cost of Madan Bhandari International
  Football Stadium at Damak-3, Jhapa, Nepal and intends to apply part of the funds to cover eligible payments
  under the Contract for Madan Bhandari International Football Stadium at Damak-3, Jhapa, Nepal (Contract
  No: Madan Bhandari International Football Stadium at Damak-3, Jhapa, Nepal). Bidding is open to all
  eligible bidders as per Section V of Bidding Document
- National Sports Council invites electronic bids from eligible bidders for the construction of Madan Bhandari International Football Stadium at Damak-3, Jhapa, Nepal under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 1440000000 Minimum Work experience of similar size and nature: At least 1 Contracts within the last ten (10) years, each with a value of at least NRs 3.1 billion without VAT that have been successfully or are substantially completed and that are similar to the proposed works.

## The similarity shall be

- At least one construction contract of World Athletics (earlier IAAF) Approved class-I Eight Lane 400
  M Athletics Synthetic Track that has been successfully completed within the last five years.
- At least one construction contract of International Football ground of Natural Grass field as per FIFA standards.
- At least one vacuum powered drainage and aeration of 6100 Sqm system that has been successfully completed within the last 5 years.
- Bidder should have the experience of having installed gallery seating of minimum 30400 of the proposed seating capacity for this project
- The bidder should have prior proven experience in designing, supplying and installing a galvanised steel
  modular grandstand (without any nuts and bolts) in a Seismic Zone V in South Asia in the last 5 years
  which has factored in structural (static & dynamic) load and wind load analysis (using SAP/
  STAAD/equivalent software) with detailed drawings and the structural designs be certified by Structural
  Peer Review Agency.
- Manufacturer should have been in the business of modular galleries for a minimum of 10 years
- Product proposed should be of European or American origin only having all steel components hot dipped galvanised inside and outside.
- Product proposed for modular gallery, synthetic athletic track, artificial turf and sub-surface vacuum powered drainage and aeration system should be of European or American origin only
- The bidder should have prior project experience and credentials of constructing modular grandstands using steel galvanised as per specifications of NF ISO 1461/equivalent and zinc coating as per NF ISO 14713-1/equivalent
- The RCC and steel structural system design s designs be certified by Structural Peer Review Agency strictly conforming to European or American equivalency.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of National Sports Council, Kathmandu, Kathmandu, Kathmandu, Bagmati Province, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- Bidder must submit their bid electronically. The bidding documents may download the bidding documents

- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 30-05-2021 12:00. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 30-05-2021 13:00 hours at the office of National Sports Council, Tripureshwor, Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 130000000 which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
