3. The last date of submission of the bids in sealed envelope is 17.03.2025 upto 03:00 pm. The bids must be dropped in the tender box kept at following address and same will be opened on 24.03.2025 at 03:30 pm in the presence of participating bidders.

4. A bidder must be/have a person/registered firm.

5. H-1/successful bidder will be decided per vehicle.

6. The conditional bid shall not be accepted.

7. The vehicle will be sold on "As is where is & whatever there is basis" and no guarantee or certificate of its worthiness or quality will be given by our department. No requests for inspection of vehicle other than as mention above (specified day & time) will be entertained.

8. The bidder shall furnish Earnest Money Deposit mentioned above by way of Demand Draft/ Pay Order/Cheque issued by a scheduled commercial bank in favor of 'Embassy of India, Kathmandu' payable at Nepal SBI Ltd., Extension Counter, Embassy of India, Kathmandu. The EMD of the unsuccessful bidder shall be returned subsequent to the award of contact to the successful bidder. No claim lies against Embassy of India in respect of erosion in the value or interest on the amount of EMD (i.e. EMD will be interest free). The bid without EMD will be summarily rejected.

10. The sold items are to be lifted from the site within a specified date from the issue of release order or such period as may be decided by the authority on an "as is where is and whatever there is basis".
