**Corrigendum**

Reference tender ID no. **2021\_MEA\_581902\_1 (tender reference no. Kat/Civil/872/02/2021) dated 07 January 2021** inviting sealed quotations from reputed and experienced bidders for **“Painting of boundary wall of Embassy of India Campus, Kathmandu.”**

2. In the said tender, paint to be used for above work was mentioned as **Asian Water Proofing Cement Paint**. In view of the limited availability of Asian Water Proofing Cement Paint in Nepal, we have now changed the type of paint to be used. The paint to be used now is **Asian Ace Exterior Emulsion paint (over the coat of Asian exterior primer)**. **It may be noted that for use of exterior emulsion paint, a coat of exterior primer will also be required.**

3. The last date of receipt of bids in sealed envelope has also been extended (from earlier 29 Jan 2021 at 1300 hrs) to 12 February 2021 up to 1300 hrs. The bid opening will be on the same day i.e. 12 February 2021 at 1600 hrs.

4. All interested bidders may kindly submit their bids as per the revised details i.e. use of **Asian Ace Exterior Emulsion paint (over the coat of Asian exterior primer)**. The **revised scope of work** for submission of bids has also been attached.

1	<b>Experience</b>	The company/contractor should have minimum two year's experience. Documentary proof from minimum three clients should be attached.
2	<b>Registration No.</b>	The company/contractor should have a valid Registration Number either in India and/or Nepal. <i>(Documentary proof should be attached)</i>

1. The Agency must be registered for collecting and depositing Tax with the Tax Department and a copy of registration certificate to this effect, duly signed and stamped by the authorized person of the Company must be enclosed with the quotation(s)/bids.
2. Successful bidders will be required to execute the work in Embassy premises on credit. Payments to the Agency will be made within reasonable period through crossed Cheque after successful completion of work.
3. This rate agreed upon should be valid for a minimum period of **six months** from the date of agreement.
4. Paint use for painting should be of **Asian Water Proofing Cement Piant**.
5. Liability period of Painting should be for minimum One years. Within Liability period any defects arises should be rectified free of cost.
5. Embassy reserves the right to terminate the contract in case the Agency/contractor's services/works are of substandard quality.
6. Embassy of India, Kathmandu reserves the right to reject/accept any sealed quotation/s without assigning any reason thereto.
7. **The Bank guarantee/DD should be valid for a period of 180 days from the date of opening of bids and should be payable at Kathmandu only.**
8. **Earnest Money will be forfeited for following reasons :-**
  - i) If the bidder withdraws his bid during the period of bid validity.
  - ii) In case of the successful bidder, if the bidder fails to sign the contract.
9. **Refund of EMD :-**
  - i) Refund of EMD to the unsuccessful bidders (Without interest) shall be made after expiry of the bid validity period and latest on or before 30<sup>th</sup> day after signing of the contract.
  - ii) EMD of successful bidder shall be refunded after award of the contract and deposit of Performance Security.
