- ii. **The bidder must be an authorized supplier of Remdesivir registered in Nepal.**
- iii. Rates quoted above shall be inclusive of all taxes/duties and final. No other charges shall be payable by the Embassy.
- iv. Price must be quoted in figures and in words. In case of discrepancy in the two, price quoted in words will be taken as valid.

- v. **Earnest Money Deposit**
 - (i) Each Bid must be accompanied with an Earnest Money Deposit (EMD) of **NRs. 2,05,000/- (Nepali Rupees Two lakh Five thousand only)** in the form of a Bank Guarantee drawn on any Nationalized/Scheduled Bank in favour of Embassy of India, Kathmandu.
 - (ii) The Bank Guarantee should be valid for a period of **120 days** from the date of opening of Bids.
 - (iii) The BG should be payable at Kathmandu only.
 - (iv) EMD must be contained in Envelope along with Bid.
 - (v) **Earnest money will be forfeited:** If the bidder withdraws his bid during the period of bid validity and In case of the successful bidder, if the bidder fails to deliver 2000 vials within 7 days of issuance of work order.
 - (vi) **Refund of Earnest Money Deposit (EMD):** (a) Refund of EMD to the unsuccessful bidders (without interest) shall be made after expiry of the bid validity or latest on or before 30th day after issue of work order. (b) EMD of successful bidder shall be refunded after successful delivery of consignment.
